9. Discuss and take action to approve Julie York's request to remodel the Extension office, including adding an additional wall to create a closet, NOT using County funds. She is acquiring an estimate from a builder as to costs.
10. Discuss and take action to approve the Antiquities Permit Application to be made by SWEPCO to the Texas Historical Commission in connection with Gilmer to Pittsburg Power Line upgrade.
11. Discuss and take action to adopt a Resolution authorizing the assignment of Private Activity Bond Authority to the Texas Department of Housing and Community Affairs (ie. Ceding authority to TDHCA from the East Texas Housing Finance Corporation) to apply for reservation of \$40M to fund bonds to pay for first time home buyers.

Discuss and take action to adopt a Resolution and taking any other action necessary to establish a County Resolution Fund (ADR System) pursuant to section 152.001 et. seq. of the Texas Civil Practice and Remedies Code, to be funded by Civil Court filing fees already mandated by section 135.101 et. seq. of the Texas Local Gov't. Code.
