In Accordance with Texas Code of Criminal Procedure Article 55A.253 the following is a list of agencies normally involved in the expunction process. This list is not all inclusive. Any outside agency that has available or published information concerning the charge or arrest should be included.

There is a \$25.00 fee for each agency included in the Petition that does not have an email address to cover the expense of certified mail to transmit application with notice and final order. The District Clerk's Office cannot provide legal advice or provide forms for filing an expunction.
